American Stewardship (“American Stewardship,” “we,” “our,” or “us”) respects your privacy and is committed to protecting the personal information you share with us. This Privacy Policy explains how we collect, use, store, and disclose information when you engage with our website (www.americanstewardship.org), our mobile application(s), donation platforms, and any related services (collectively, the “Services”).

By using our Services, you consent to the practices described in this Privacy Policy.

1. Information We Collect

a. Information You Provide

- **Personal Information:** such as your name, mailing address, email address, phone number, and payment details when you make a donation, sign up for updates, register for events, or otherwise interact with our Services.
- **Donation Information:** information required to process contributions and comply with applicable federal and state laws.
- **Communications:** information you provide when you contact us via email, forms, surveys, or feedback tools.

b. Information Collected Automatically

- **Device and Usage Data:** including IP address, browser type, device type, operating system, app version, and interactions with our Services.
- **Cookies and Analytics:** we use cookies and similar technologies to improve functionality, understand engagement, and enhance user experience. You may manage cookie preferences through your browser settings.
- **Location Data:** approximate location data derived from IP address or device settings, if enabled.

c. Information from Third Parties

We may receive information from third-party service providers such as payment processors, analytics providers, email platforms, or social media services, consistent with applicable law.

2. How We Use Information

We use the information we collect to:

- Process donations and maintain accurate records;
 - Communicate with you about our mission, programs, events, advocacy efforts, and opportunities to support American Stewardship;
 - Operate, maintain, and improve our Services;
 - Manage volunteers, supporters, and outreach efforts;
 - Comply with legal, regulatory, and reporting obligations.

3. Disclosure of Information

We may disclose information in the following circumstances:

- **Service Providers:** to trusted third parties that perform services on our behalf, such as payment processing, email delivery, data hosting, and technical support.
- **Legal Requirements:** when required to comply with applicable laws, regulations, legal processes, or government requests.
- **Organizational Purposes:** in connection with a restructuring, merger, or dissolution of the organization, consistent with applicable law.

We **do not sell** your personal information.

Additional Notice for Text Messaging

Text messaging opt-in data and consent will **not** be shared with any third parties, except as required by law.

4. Data Retention

We retain personal information only for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law.

5. Your Choices
